- This agreement is made upon the express condition that the Church shall be free from all liabilities and claims for damages and/or suits for or by reason of any injuries to any person or persons or property of any kind whatsoever, whether to the person or property of any Licensees on their persons, from any cause or causes whatsoever while in or upon said premises or any part thereof during the

time of the use herein set forth, or occasioned by any occupancy by Licensee and the public, or any activity carried on by Licensee in connecting therewith, jointly and individually covenant and agree to indemnify and hold the Church harmless from all liabilities, charges, expenses (including counsel fees) and cost on account of or by reason of any such injuries, liabilities, claims, suits or losses however occurring or damages growing out of same.

7. A certificate of insurance including the Church as additionally insured with a hold harmless clause and workers compensation must be submitted and approved before the commencing date.
